If we must cancel a trip, all payments received to date will be refunded and this constitutes full settlement. We are not responsible for expenses incurred in preparation for any trips (even cancelled trips), such as airline tickets, travel delays, flight cancellations or health problems.

Travel Insurance is highly recommended and should be arranged by you.
